## **CALL FOR PAPERS / ABSTRACTS**

The Organising Committee welcome PhD students from all third level institutions throughout Denmark, Europe and elsewhere to submit an abstract of a paper to deliver at the conference. This two-day event is an opportunity for participants to present their work, be it a portion of their thesis or standalone article for the postgraduate law conference, with all areas of the law eligible. Interdisciplinary submissions are also welcome.

For submitting an abstract, students will need to send the following: 1. Full name 2. University 3. Faculty / School / Centre / Institute 4. Abstract Title 5. Abstract (300 words maximum) 6. Research field keywords (3 maximum) 7. The **deadline** for submitting abstracts is **Friday 10 October 2014**.
